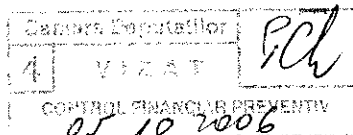
Prin memorandumul intern nr. 58/2/1077 din 21 septembrie a.c., Biroul Permanent al Camerei Deputaților a aprobat participarea domnului deputat **Adrian Severin** (PSD) la reuniunea comisiei pentru probleme politice a Adunării Parlamentare a Consiliului Europei care va avea loc la Moscova pe data de 18 octombrie 2006.

Conform prevederilor din acest memorandum, domnului deputat i s-a acordat dreptul la cazare plafon B pentru 2 nopți în numerar. Având în vedere că organizatorii solicită cazarea participanților la hotelul nominalizat de aceștia, acest lucru implică o cheltuială suplimentară peste nivelul baremului, de $106 \text{ USD} \times 2,7859 = 295,31 \text{ RON}$.

Adrian Severin (PSD).

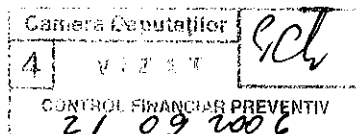
Acțiunea are caracter parlamentar conform art.3, alin. a. al HBP nr. 1/2003.
