**MEMORANDUM INTERN**

**Către:** domnul Mihai Unghianu, Secretar general adjunct al Camerei Deputaților

**Tema:** A 18-a sesiune anuală a Forumului Crans Montana (Monaco, 28 iunie – 1 iulie 2007)

În perioada 28 iunie - 1 iulie 2007 se va desfășura, la Monaco, cea de-a 18-a sesiune anuală a Forumului Crans Montana, având ca temă „Promovarea guvernării globale”.

Principalele teme care vor fi abordate în cadrul reuniunii sunt legate de problemele esențiale privind dialogul dintre civilizații, adâncirea sau micșorarea diferențelor dintre Uniunea Europeană și Statele Unite, globalizare lentă versus globalizare intensă, viitorul organizațiilor neguvernamentale în debaterile politice, infrastructura în transport după extinderea Uniunii Europene, problema securității energiei în Uniunea Europeană și politica de vecinătate.

Domnul deputat Adrian Năstase (PSD), membru al Comisiei pentru politică externă, a fost invitat să participe la această reuniune.

**Acțiunea se încadrează în prevederile articolului 5, litera b din HBP 1/2003.**

**Propunem:**

- să se aprobe participarea domnului deputat Adrian Năstase la acțiunea menționată, cheltuielile de participare urmând a fi suportate din bugetul Camerei Deputaților;
- deplasarea să se efectueze cu avionul, pe ruta București - Roma - Nisa și retur, cu plecare în data de 27 iunie 2007, ora 14:20 (AZ 501) și întoarcere în data de 2 iulie 2007, ora 17:15 (AZ 494);
- să se acorde drepturi de diurnă categoria I, 100%, pentru 5 ½ zile, cazare pentru 5 nopți la Monte Carlo Bay Hotel & Resort, indicat de organizatori, care va fi și locul de desfășurare a reuniunii;

- să se acorde suma de 200 euro pentru cheltuielile de transfer Nisa - Monaco și retur;
- recalcularea cheltuielilor se va face la întoarcerea în țară, pe baza documentelor justificative.

### FORUM REGISTRATION

Heads of State, Prime Ministers, Members of Government and their senior assistants, State Officials, Diplomats, and their senior assistants, Officials from International and non Governmental Organizations, University officials and faculty with no other paid activity, **do not pay the Registration Fees to attend the Forum Sessions.**

Confirmation of Participation will be sent upon receipt of the registration form, by postal mail, fax or email.

### MULTI-SERVICES PACKAGE

#### WITH HOTEL:

You may select one of the packages offered depending on the categories of rooms chosen at the Monte-Carlo Bay Hotel & Resort.

Four categories of rooms are available: Standard, Deluxe with sea view, Duplex/JuniorSuite and Suite. The rooms are available on a first come first served basis.
