Doamna deputat **Florina Ruxandra Jipa (PRM)**, domnii deputați **Cristian Silviu Bușoi (PNL)** și **Florin Iordache (PSD)**, membri ai Comisiei de apărare, doamna deputat **Anca Petrescu (PRM)**, membru al Comisiei pentru relații parlamentare și publice, domnii deputați **Nicolae Popa (PC)** și **Alexandru Ungureanu (PSD)**, membri ai Comisiei politice, precum și domnul Daniel Dulca, secretarul delegației parlamentare române la AUEO, vor participa la reuniunile acestor comisii, care vor avea loc la Paris în data de 3 aprilie a.c.

Pe agenda acestor reuniuni figurează: adoptarea proceselor-verbale ale reuniunilor anterioare, prima lectură a rapoartelor, prezentarea în cadrul Comisiei pentru relații parlamentare și publice a contribuției doamnei deputat Anca Petrescu în calitate de coraportor, audierea doamnei Sylvie Goulard, președintele Mișcării Europene Franceze, discutarea programului pe anul 2007 al Adunării, precum și stabilirea datei și locului viitoarelor reuniuni.

Acțiunea are caracter parlamentar, potrivit art. 3 lit. a. din HBP nr.1/2003.

Propunem:

- să se aprobe participarea delegației parlamentare române la acțiunea de la Paris;
- deplasarea să se efectueze cu avionul pe ruta București-Paris și retur, cu plecare în ziua de 2 aprilie, ora 09.15 (zbor RO 381) și întoarcere în ziua de 4 aprilie, ora 20.20 (zbor RO 384), conform traseului anexat;
- să se acorde drepturi de diurnă cat. a-II-a, 100% pentru 2 ½ zile, drepturi de cazare plafon B pentru 2 nopți, precum și un avans de 50% cu decontare ulterioară;
- recalcularea cheltuielilor să se facă la întoarcerea în țară, pe baza documentelor justificative.
