Propunem:

**GOPAC Conference South East Europe
Tirana, Albania – September 2007**

The purpose of the conference is to bring together parliamentarians from countries in South East Europe to create a regional chapter of the Global Organization of Parliamentarians Against Corruption (GOPAC).

Establishing a regional chapter of GOPAC will provide parliamentarians in the region with a solid, global, base of support for developing knowledge and implementing anti-corruption initiatives. Parliamentarians will benefit from participating in a global organization, which provides: a) peer support b) opportunities for developing knowledge and skills; and c) political leadership and mechanisms through which to develop coalitions to implement both regional and global anti-corruption agendas. Participating parliamentarians will subsequently be equipped to create national chapters of GOPAC in their respective countries.

The Parliament of Albania has graciously accepted to host the proposed conference.

Conference date: 3rd to 5th October, 2007

Expected participants: 60-80 parliamentarians from the following parliaments: Albania, Serbia, Bosnia and Herzegovina, Macedonia, Montenegro, Kosovo, Bulgaria, Romania, Slovenia (TBC) and Croatia.

Dear Hon. Speaker,

It is with the utmost pleasure that we extend an invitation for a delegation of members from your parliament to attend a regional conference of the Global Organization of Parliaments Against Corruption (GOPAC) to be held in the Parliament of Albania in Tirana from 3rd to 5th October, 2007. The conference is the joint initiative of the Parliament of Albania (National Security Committee) and GOPAC.

This premiere event will bring together parliamentarians from various parliaments in South East Europe, who share the common objective of combating corruption, to establish the consensus to advance anti-corruption agenda both regionally and globally. This will engage parliamentarians in the region to become leaders in the fight against corruption with the desired outcome of establishing a regional chapter of GOPAC.

GOPAC was founded in 2002 at a global conference hosted by the Parliament of Canada. Since 2002, GOPAC has expanded rapidly and is now represented in close to 80 countries around the world. Membership is continues to grow and GOPAC is gaining recognition as a democratic voice, promoting parliamentary oversight as one of the fundamental weapons in the fight against corruption.

GOPAC has a clear mission to reduce corruption by improving the effectiveness of parliaments as democratic institutions of oversight of government. To accomplish this mission, GOPAC activities supported by three pillars:

1. **Peer support for parliamentarian.** In many parts of the world, standing up against corruption is a challenging and sometimes perilous task for a parliamentarian to undertake. Membership in an informed and credible goal organization of peers provides an additional measure of security for individual parliamentarians challenging corruption in difficult circumstances.
2. **Education for Parliamentarians.** We send our young people to university to become lawyers, doctors, engineers and accountants, but who teaches parliamentarians how to do their job of overseeing the work of government? Parliamentarians need to understand their constitutional rules, powers, authorities and responsibilities in order to work effectively. Providing access

to expert organizations, experienced colleagues, and training opportunities are key steps in building effective parliamentary oversight.

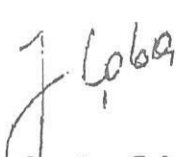
3. **Leadership for results.** Parliamentarians need to be leaders in the fight against corruption. Parliament has the constitutional authority and responsibility to hold its government accountable. Parliamentarians have political capacity, which, when combined with the technical capacity of expert agencies and key stakeholders can significantly advanced anti corruption initiatives.

We would greatly appreciate your assistance in identifying 6-10 parliamentarians who have shown a strong commitment to the fight against corruption. In choosing these candidates, please keep in mind equitable representation of women and of both governing and opposition political parties in parliament.

About GOPAC

The Global Organization Against Corruption (GOPAC) is an international network of parliamentarians dedicated to good governance and combating corruption throughout the world. Founded in 2002 at a conference hosted by the Canadian House of Commons and Senate, GOPAC has over 400 members around the world, organised into regional and national chapters.

What Does GOPAC do?

Incorporated under Canadian law as a not-for-profit organization, GOPAC is guided by a global Board of Directors selected by regional chapters. The Board's Executive Committee is chaired by John Williams, Member of Parliament, Canada. Musikari Kombo (MP, Kenya) and Dr. Naser Al-Sane (MP, Kuwait) are its Vice Chairs.

In addition to developing regional chapters, member information services, and building alliances, GOPAC has identified a number of specific agenda items for 2002-2006, including:

- Handbook for parliamentarians on controlling corruption;
- A training/orientation package for parliamentarians on the budgetary and financial oversight role of parliamentarians;
- A code of conduct for parliamentarians;
- Indicators of performance for parliamentary oversight;
- Parliamentarians with an anti-money laundering agenda; and
- Implementing the United Nations Convention Against Corruption (UNCAC).

GOPAC focuses on three pillars to build an effective organization.

1. Peer Support

Every organization needs to support its members and that is especially important for GOPAC and its regional chapters. In some parts of the world, legislators are in fear of their lives if they speak out against corruption. They need to know that they do not stand alone, there are legislators who are prepared to speak out with them and there is strength in numbers.

2. Education

It is becoming increasingly obvious that there is a serious need for education of parliamentarians on what is their role and responsibilities as parliamentarians. Many parliamentarians are confused and do not understand the separate roles of government and parliament. These are two distinct institutions with totally different roles

and responsibilities.

In a democracy, a government has the authority to govern, subject to the approval and oversight of the parliament, which in turn is accountable to the electorate through fair open transparent and competitive elections.

There are four fundamental responsibilities of a parliament in the exercise of oversight of government.

To debate, modify, approve or reject legislation.

To debate, modify, approve or reject authority for government to raise revenues through taxation and other means.

To debate, modify, approve or reject proposed expenditures by government.

To hold executive accountable for its governance of society.

Far too often, parliamentarians see their roles as supporting the government at any cost if they are a member of the governing party or opposing the government regardless of the merits of its proposals when they are in opposition.

In a properly functioning democracy, a government is accountable to the parliament as a whole, where the members bring a diversity of opinion to the debate but are still required to exercise their considered judgement on the proposals by government and the performance of government.

3. Clear objectives, measurable results

Members of an organization develop stronger affinity to the organization when they clearly understand what is expected of them. Each Chapter of GOPAC is entitled to identify and develop its own objectives and be accountable for the results.

For example, our Latin American Chapter has chosen to identify the progress (or lack thereof) that their governments have made in introducing the legislation necessary to implement the Santiago Convention Against Corruption. In the Caribbean, the new Chapter has recognized the need to improve the effectiveness of the Public Accounts Committees which are Standing Committees of the Legislature focused on accountability.

The Parliamentary Centre and GOPAC

The GOPAC secretariat is located in the Parliamentary Centre in Ottawa, Canada. It is, however, an independent financial entity within the Centre. GOPAC purchases secretariat services from the Parliamentary Centre as they are used. Relations between GOPAC and the Parliamentary Centre are described in a memorandum of understanding. The Executive Secretary of GOPAC, an associate or employee of the Parliamentary Centre, reports directly to the Chair on GOPAC business and is responsible for all resources assigned to it by GOPAC.

Parliaments as Peacebuilders

Parliaments play critical roles in conflict prevention, peacebuilding and post-conflict reconstruction.

Peace and security requires executive bodies to act with efficiency and effectiveness, but it also requires representation and accountability: two core functions of parliaments. Parliaments connect citizens with the state and hold governments to account. They are natural places for mediation, where competing points of view are articulated and where dialogue can build consensus. These core functions are essential in mitigating and resolving conflict.

More and more emerging democracies are interested in developing parliamentary capacity in the areas of conflict prevention, peacebuilding and post-conflict reconstruction and the Parliamentary Centre together with partners around the world are responding to this opportunity.

- Share Parliamentary Centre research and writing;
- Describe our initiatives in this area and what we are learning from conflict-affected contexts; and
- Provide a map to the work of our partners who are engaged in these areas.
