 - să se suporte din bugetul Camerei Deputaților suma de 200 RON/persoană, reprezentând contravaloarea vaccinului împotriva febrei galbene (art. 56, ali.1, lit.b din HBP 5/2007);

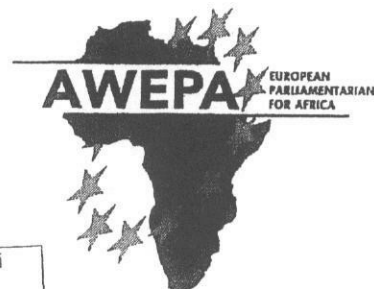

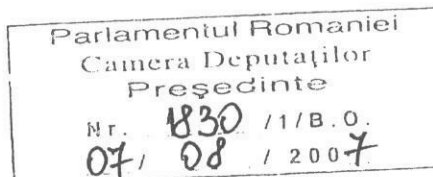

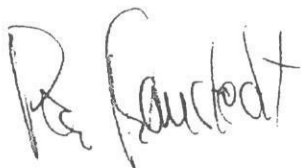

Draft Terms of Reference (ToR)

EU (German) Presidency Seminar **Strengthening the Role of Parliamentary Oversight and Budget Control in African Development** – focus on NEPAD and CAADP¹

Cotonou, Benin, 3-4 October 2007

Pan-African Parliament, ECOWAS Parliament, Parliament of Benin, German
Bundestag, AWEPA

Background

This activity is part of the parliamentary support programme "Mobilising Parliaments for NEPAD" (MPN)², aimed at facilitating a greater involvement in the NEPAD process for African and European Parliaments, by raising awareness and promoting parliamentary action in various areas of development relating to the NEPAD initiative.

The role of parliamentary oversight and budget control are paramount to Africa's development. Members of Parliament (MPs) in Africa and Europe can effectively fulfil their oversight roles in support of development work through budget control and legislation. The acceleration of CAADP implementation at the national level, having been given high priority by the African Union and NEPAD, is the MPN priority for 2007³. Bearing in mind the Millennium Development Goal #1 (Eliminate hunger and poverty reduction), and the Paris Declaration follow up process, parliamentary oversight function around agricultural development will also be addressed as it relates to poverty reduction, climate change (water and desertification), and women's rights (property and inheritance rights).

Objective

The objective of the EU Presidency Seminar is to:

- Enhance Member of Parliament's (MP) expertise on the role of parliamentary oversight and budget control, especially as it relates to NEPAD and CAADP, in order to strengthen oversight and budget control capacity supporting good governance;
- Enhance Member of Parliament's (MP) expertise on CAADP as it is related to poverty reduction (rural development, gender) and sustainable development (climate)
- Sensitise European Parliamentarians about their role in championing ODA oversight against the background of the Paris Declaration;
- Assist in prioritising CAADP national implementation by identifying necessary parliamentary procedures and legislation for efficient parliamentary budget control;
- Develop recommendations on what MPs can do in view of national parliamentary procedures and legislation for efficient parliamentary budget control in general as well as regarding the implementation of NEPAD and CAADP (the basic document to be discussed will be the draft *Framework for Parliamentary Action on CAADP*, developed during an Expert Meeting in March 2007);
- Facilitate an exchange between African and European MPs on the role European MPs can play in supporting CAADP implementation and in monitoring government performance in Europe and in Africa in the context of aid effectiveness (*Paris Declaration*).

Expected Outputs

- MPs in the West Africa region and European MPs were briefed on the on the role of parliamentary oversight and budget control, especially as it relates to NEPAD and the CAADP agenda, with a special focus on the role parliament can play in achieving the goals of NEPAD and the CAADP;
- MPs in the West Africa region and European MPs were provided with a forum for championing parliamentary oversight and budget control, especially as it relates to the CAADP agenda, and the special needs for agricultural development in the West Africa region, including women's rights;
- MPs in the West Africa region identified measures to integrate more support to parliamentary procedures and legislation for efficient parliamentary budget control, especially agriculture development into their parliamentary work and developed an Action Plan on the topics discussed;
- MPs reached agreement on ways to improve oversight capacity: tracking progress of their governments' commitments/pledges to support agriculture nationally and regionally (for European MPs relating to the Paris Declaration, for African MPs relating to the implementation of NEPAD and CAADP as well as in the context of new aid modalities such as budget support, sector-wide approaches, etc.);
- MPs identified key capacity building needs to ensure an improvement of parliamentary procedures and legislation for efficient parliamentary budget control.

Expected Outcomes

- The tabling of the Action Plan within the national parliaments, led to better awareness on parliamentary procedures and legislation for efficient parliamentary budget control, especially relating to NEPAD and the CAADP, within the national parliaments in the West African region;
- Measures to integrate the CAADP agenda, including women's issues, into parliamentary work were undertaken;
- The increased information on parliamentary procedures and legislation for efficient parliamentary budget control as well as on NEPAD and CAADP assisted the national parliaments to improve their oversight of parliamentary and government action nationally and regionally;

- The national parliaments will have better informed debates and decision-making on progress on budget control during committee meetings and plenary sessions.

Partners, Participants and Resource Persons

The activity is hosted by the Benin Parliament and facilitated [jointly] by the Pan-African Parliament (PAP), the ECOWAS Parliament, The German Bundestag and AWEPA.

The participation policy is to strongly advocate the principles of gender-balance and multi-party representation.

The participants (around 85) will be:

- MPs from 15 West African states (2 per country) from Agriculture Committees, (30)
- MPs from the 15 West African States (1 per country) from Pan-African Parliament (PAP) or ECOWAS Parliament members (15)
- MPs from European Union States (10)
- The Chair of the PAP Committee on Rural Economy, Agriculture, Natural Resources and Environment (1)
- The Chair of The ECOWAS Committee on Rural Development (1)
- The Chair of ECOWAS Committee on Economy, Finance and Trade (1)
- The Chair of ECOWAS Committee on Women's and Children's Rights (1)
- Resource Persons will be drawn among experts from the NEPAD Secretariat, FAO, UNEP, UNECA, IFAB, IFAD, AU) (total of 5-10)
- 2 representative from the NEPAD Contact Group of African Parliamentarians (NCGAP) and the African Parliamentarian's Forum on NEPAD (Chair and 1 member) (4)
- 2 representatives from the Réseau des Femmes Parlementaires d'Afrique Centrale (RFPAC) (2)
- AWEPA representatives

Date and Venue
