În perioada 21 – 26 ianuarie 2007, la Strasbourg, se va desfășura prima parte a Sesiunii ordinare 2007 a Adunării Parlamentare a Consiliului Europei, la care participă membrii și secretariatul delegației, respectiv doamna deputată Minodora Cliveti (PSD), domnii deputați Cezar Preda (PD), Ștefan Glăvan (PC), Adrian Severin (PSD) și Mihai Tudose (PSD), precum și doamna Nadia Ionescu, director, secretara Delegației Parlamentului României la A.P.C.E.

- deplasarea domnilor deputați Cezar Florin Preda și Adrian Severin să se facă cu avionul pe ruta București – Strasbourg- București, cu plecare în data de 21.01.2007, ora 17.10 (LH 3421) și întoarcere pentru domnul deputat Cezar Florin în data de 27.01.2007, ora 11.50 (LH 3424), iar pentru domnul deputat Adrian Severin în data de 26.01.2007, ora 00.10 (LH 3422) conform traseului alăturat și solicitării celor doi domni deputați;

 - doamnei deputate Minodora Cliveti, domnilor deputați Ștefan Glăvan și Mihai Tudose și doamnei directoare Nadia Ionescu pentru 8 zile și 7 nopți ;
 - domnului deputat Cezar Florin Preda pentru 6 zile și 6 nopți;
 - domnului deputat Adrian Severin pentru 4 ½ zile și 4 nopți

- să se acorde un avans de 50% cu decontare ulterioară;
- să se acorde o sumă de 500 de Euro pentru cheltuieli de protocol în vederea organizării, cu sprijinul Reprezentanței permanente a României la Strasbourg a unei acțiuni protocolare (menționăm că Senatul va contribui cu aceeași sumă);
- recalcularea cheltuielilor să se facă la întoarcerea în țară, pe baza documentelor justificative.
