(Sankt-Petersburg, 31 mai -1 iunie 2007)

În perioada 31 mai-1 iunie a.c. urmează să se desfășoare la Sankt-Petersburg o reuniune comună pe probleme de Politică Europeană de Securitate și Apărare, precum și conferința cu tema "Dialogul culturilor și confesiunilor în noul secol: perspective și probleme".

La care acțiuni sunt invitați să participe membrii Comisiei politice a Adunării Uniunii Europei Occidentale (AUEO), Comisiei permanente pe probleme politice și cooperare internațională a Adunării interparlamentare a Comunității Statelor Independente (CSI), precum și ai Comisiei politice a Adunării parlamentare a Consiliului Europei.

Din partea delegației parlamentare române la AUEO urmează să participe doamna deputat Florina Ruxandra Jipa (PRM), președinta delegației, domnii deputați Alexandru Ungureanu (PSD) și Nicolae Popa (Independent), membri ai Comisiei politice a Adunării, precum și domnul Răzvan Tănase, secretarul delegației parlamentare române la AUEO

Acțiunea are caracter parlamentar, potrivit art. 3 lit. a. din HBP nr.1/2003.

Propunem:

- să se aprobe participarea delegației parlamentare române la acțiunea mai sus-menționată;

- deplasarea să se efectueze cu avionul pe ruta București-München-Sankt-Petersburg și retur, cu plecare în ziua de 30 mai, ora 07.05 (zbor LH 3425) și întoarcere în ziua de 2 iunie, ora 23.59 (zbor LH 3424), conform traseului anexat;

- să se acorde drepturi de diurnă cat. a-II-a, 100% pentru 4 zile, drepturi de cazare plafon B pentru 3 nopți, în numerar, precum și un avans de 50% cu decontare ulterioară;

- recalcularea cheltuielilor să se facă la întoarcerea în țară, pe baza documentelor justificative.
