Tema: Participarea la lucrările Biroului și Comisiei Permanente ale Adunării
Parlamentare a Consiliului Europei (Paris, 15 – 16 martie 2007)

În zilele de 15 și 16 martie 2007, la Paris se vor desfășura reuniunile Biroului și Comisiei Permanente ale Adunării Parlamentare a Consiliului Europei (A.P.C.E.), din care face parte domnul deputat Cezar Florin Preda (PD), vicepreședinte al A.P.C.E.

Reuniunea Comisiei Permanente va fi consacrată dezbaterii și adoptării mai multor rapoarte, între care raportul domnului deputat Cezar Florin Preda, privind deșeurile urbane, și raportul doamnei deputate Grațiela Iordache, privind consumul etic și responsabil. Întrucât doamna deputată Grațiela Iordache nu mai face parte din Delegația Parlamentului României la A.P.C.E., raportul elaborat de domnia sa va fi susținut de domnul deputat Cezar Florin Preda în calitate de vicepreședinte al Comisiei pentru probleme sociale, sănătate și familie, conform prevederilor Regulamentului A.P.C.E.

Acțiunile au caracter parlamentar conform art.3, alin. a. al HBP nr.1/2003

Propunem:

- să se aprobe participarea domnului deputat Cezar Florin Preda și a doamnei Nadia Ionescu, Secretara Delegației Parlamentului României la A.P.C.E., la aceste acțiuni;
- deplasarea să se facă cu avionul pe ruta București – Paris și retur, cu plecare în 14 martie 2007, ora 09.25 (RO 381) și întoarcere în 17 martie 2007, ora 20.20 (RO 384) conform traseului alăturat;

- să se acorde drepturi de diurnă categoria a II-a, 100%, pentru 3 1/2 zile, cazare plafon B pentru 3 nopți și un avans de 50% cu decontare ulterioară;
- recalcularea cheltuielilor să se facă la întoarcerea în țară, pe baza documentelor justificative.
