Propunem:

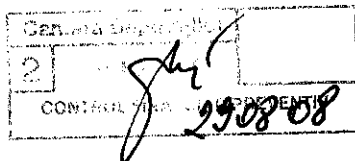
- să se aprobe participarea membrilor delegației, menționați mai sus, la această acțiune;

5. Proposals for cooperation among the BSEC Member States in promoting globalization while managing some of its potentially negative effects on social equality and welfare.

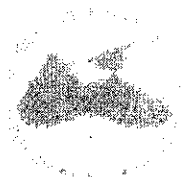
Please take note that the national delegations are to provide their contributions by **1 August 2008 at the latest**.

The Draft Minutes of the 30th Meeting of the Committee, held on 26 March 2008 in Sofia, were circulated to the National Delegations on 29 April 2008. **There will be no distribution of this document in Alexandroupoli**. The participants are kindly requested to make sure they have a copy during the meeting.
5. The National Delegations are requested to be prepared to propose the main subject to be placed on the agenda of the next meeting of the Committee.
6. The date and venue of the next meeting shall be decided according to the Decision 5/1997 of the Standing Committee.
7. Following the Decision of the Bureau of 19 June 1997 the host country shall fully cover the board and lodging expenses **only for the members of the Committee and one Secretary from each delegation and the International Secretariat**.
8. The National Delegations are kindly asked to confirm their participation and provide the corresponding arrival/departure details by 15 September 2008.
