Comisia pentru afaceri europene a Parlamentului României a organizat în colaborare cu Parlamentul Lituaniei și cu Oficiul TAIEX din cadrul Comisiei Europene, o vizită de studiu la Vilnius, Lituania, în perioada 17-21 martie 2008.
