Domnul deputat Alin Teodorescu a fost selectat, în cadrul programului Europa Aid coordonat de Comisia Europeană, să facă parte din grupul observatorilor de scurtă durată la alegerile parlamentare din Pakistan. Comisia Europeană asigură misiuni de observare a alegerilor parlamentare, locale și prezidențiale în diferite țări ale lumii prin selectarea participanților dintr-o bază de date unică.

Menționez că toate cheltuielile legate de participarea la misiunea de observare sunt suportate de Organizația Internațională a Migrației, contractorul general al Comisiei Europene pentru programul de observare a alegerilor prin programul Europa Aid.

Acțiunea se încadrează în prevederile art.3, lit.c, din HBP 1/2003 modificată și completată prin HBP nr. 5/2007.

Propunem :

- să se aprobe participarea domnului deputat Alin Teodorescu la această acțiune;

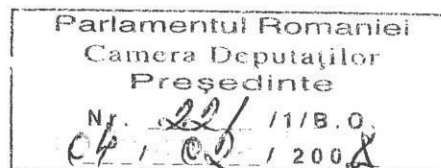

Prin programul *Europe-Aid*, Comisia Europeană asigură misiuni de observare a alegerilor parlamentare, locale și prezidențiale în diferite țări ale lumii. Menționez că toate cheltuielile logistice – transport, cazare și servicii de protecție - sînt asigurate de IOM, contractorul general al Comisiei Europene pentru programul de observare a alegerilor *Europe-Aid*.

Dear Mr. Teodorescu,

The International Organization for Migration wishes to congratulate you for having been selected as Short Term Observers for the European Union Election Observation Mission to Pakistan. Acting as the European Commission Implementing Partner for this operation, IOM - on behalf of the EC - will provide logistical and administrative support and assistance to the EU EOM both in Europe and in Pakistan.

Markus Pirchner of AidCo informed us to arrange your deployment to Pakistan. In order for us to start making all the necessary arrangements, we would need you to **confirm your availability to depart for the mission by tomorrow 24th of January at 14:00.**

You will be required to participate in a **training on security** in Pisa from the 5th to the 8th of February. You will provisionally be deployed to Pakistan on the 9th or 10th of February. Your return is scheduled for the 21st or 22nd of February. We will keep you informed with regards to flights.

Please note that the European Commission will take a final decision on your deployment only on the 4th or 5th of February.

The main time constraint for departure is obtaining your visa. Please send us as soon as possible a scanned **copy of your valid passport**. Please save it as "YOUR SURNAME-Your Name-PPT" (i.e. "SCHMIDT-Bruno-PPT"). We need to receive this **by tomorrow at 14:00** at the very latest, as well to confirm logistical arrangements for the training in Pisa.

For the visa and accreditation, please send by **Friday 25th at the very latest:**

Basic and Advanced Security in the Field (B/ASITF) certificates

The EU EOM Pakistan will follow the United Nations Department of Safety and Security (UNDSS) regime. This implies that individual UN security-related training is **compulsory** for all members of the Mission. After carefully reading the attached *Updated Instructions UNDSS Security Training*, please complete the **Basic and Advanced Security in the Field (B/ASITF) courses** and send us both certificates by e-mail. **Failure to do so will**

prevent you from participating in the Security Training in Pisa and departing for the Mission.

Please save the certificates as follows: "YOUR SURNAME-Your Name-BSITF" for the basic course and "YOUR SURNAME-Your Name-ASITF" for the advanced course.

In the meantime please read the attached *Medical Advice for Pakistan* and consult your general practitioner. Please consider that the vaccinations indicated in the attached document are compulsory, and will be reimbursed upon receipt of original invoices by IOM Brussels (address in signature below).

You will also have to provide us as soon as possible with the following mandatory medical documents:

- Scanned copy of the **Electrocardiogram (ECG/EKG)** recording;
 - o Please save it as "YOUR SURNAME-Your Name-ECG".
- Scanned copy of the **Fit-to-Work certificate** provided by a practicing doctor showing **no diabetes** and **ability to work in conditions of hardship**.
 - o Please save it as "YOUR SURNAME-Your Name-FTW".
- **Scanned copy of your updated Vaccination Card;**
 - o Please save it as "YOUR SURNAME-Your Name-Vacc Card".
