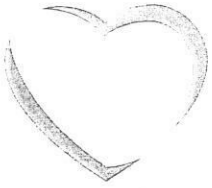

- Police cooperation

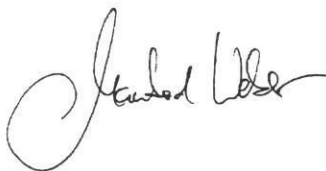
