- deplasarea să se efectueze cu avionul, pe ruta București-Istanbul-Izmir și retur, cu plecare în data de 28 aprilie 2009, ora 8.35 (RO 261) și întoarcere în data de 1 mai 2009, ora 19.45 (RO 264);

- să se acorde drepturi de diurnă categoria a II-a, 50%, pentru 3 1/2 zile și un avans de 50% cu decontare ulterioară;
- recalcularea cheltuielilor se va face la întoarcerea în țară, pe baza documentelor justificative
