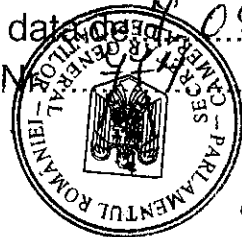

MEMORANDUM INTERN

Tema: Participarea la lucrările Comisiei generale pentru probleme economice a Inițiativei Central-Europene - Dimensiunea Parlamentară (Zagreb, Croația, 21 septembrie 2009)

Domnul Milorad Pupovac, președintele Comisiei generale pentru probleme economice a Inițiativei Central-Europene - Dimensiunea Parlamentară (ICE - DP), a adresat membrilor acestei comisii invitația de a participa la reuniunea Comisiei care se va desfășura la Zagreb, Croația, la data de 21 septembrie a.c.

Tema propusă de organizatorii reuniunii este "Reflecție despre criza economică globală în regiunea ICE; ce pot face parlamentarii pentru a o învinge?". Agenda reuniunii include și alegeri pentru poziția de președinte al Comisiei.

Potrivit art. 10 din Regulamentul ICE - DP, la reuniune participă de drept membrii Comisiei generale pentru probleme economice a ICE - DP.

Din partea Camerei Deputaților participă domnul deputat Aurel Vainer, vicepreședinte al Comisiei pentru politică economică, reformă și privatizare (Grupul parlamentar al minorităților naționale), care este membru al Delegației Parlamentului României la ICE - DP și membru în Comisia generală pentru probleme economice a ICE - DP.

Acțiunea are caracter parlamentar (art. 3, lit. d din HBP nr. 1/2003 cu modificările și completările din HBP nr. 5/2007) și este inclusă în Programul anual de relații externe al Parlamentului României.

Propunem:

- să se aprobe participarea la această acțiune a domnului deputat Aurel Vainer;
- deplasarea să se efectueze cu avionul pe ruta București – Budapesta - Zagreb și retur, cu plecare la 20 septembrie a.c., orele 16.10 (zbor MA 853) și întoarcere la 23 septembrie a.c., orele 01.25 (zbor MA 856);
- să se acorde cazare plafon B pentru 2 nopți Croația, în perioada 20-22 septembrie a.c.;
- să se acorde drepturi de diurnă categoria a II-a, 100%, pentru 2 ½ zile și un avans de 50% cu decontare ulterioară;
- recalcularea cheltuielilor să se efectueze la întoarcerea în țară pe baza documentelor justificative.
