**privind participarea la Reuniunea Parlamentară Comună cu tema
"Spre o Comunitate Europeană a Energiei pentru Secolul 21 ?"**
- Bruxelles, 7-8 iunie 2010 -

În perioada 7-8 iunie 2010, Parlamentul European și Parlamentul Spaniei, țară care deține Președinția Uniunii Europene, au organizat, la Bruxelles, la sediul Parlamentului European, Reuniunea Parlamentară Comună cu tema "Spre o Comunitate Europeană a Energiei pentru Secolul 21 ?".

Reuniunea a fost co-prezidată de domnii Jerzy Buzek, Președintele Parlamentului European și Javier Rojo, Președintele Senatului spaniol.

Din partea Camerei Deputaților a participat domnul deputat Doru Brașoan Leșe (Grupul parlamentar PD-L), membru al Comisiei pentru afaceri europene a Parlamentului României și al Comisiei pentru industrii și servicii din Camera Deputaților.

Au fost prezenti peste 250 participanți, astfel: din 20 de parlamente naționale ale statelor membre ale Uniunii Europene, din parlamentele naționale ale statelor candidate (Croatia și Turcia), din partea Parlamentului European și a altor instituții ale Uniunii Europene și din mediul academic.

În preambulul Reuniunii Parlamentare Comune au avut loc, separat, întâlniri ale grupurilor politice din Parlamentul European cu membrii din parlamentele naționale.

În alocuțiunea de deschidere domnul Buzek și-a exprimat susținerea sa pentru crearea unei noi comunități europene dotată cu o piață unică a energiei pe deplin funcțională, prin utilizarea de rețele integrate, corectate de măsuri de stabilizare a prețurilor, la care se adaugă complementar politici de inovare.

În apelul său pentru sprijin adresat parlamentelor naționale și guvernelor, vorbitorul a afirmat că este necesară implementarea legislației existente și măsuri pentru a-i da acesteia mai multă substanță.

Domnul Buzek a afirmat că principalele elemente ale propunerii constau în interconectarea rețelelor energetice naționale, înființarea unui fond comun destinat cercetării și dezvoltării energiilor alternative și

inițierea de grupuri de achiziționare a petrolului și gazului de la furnizori din străinătate.

Tot în deschiderea reuniunii, domnul Javier Rojo, Președintele Senatului spaniol, a subliniat că energia va juca un rol fundamental în reînnoirea structurilor europene. Domnia sa a pledat pentru o politică energetică care să fie sigură, curată și securizantă pentru bunăstarea Uniunii Europene și a cetățenilor săi, prin interconectarea rețelelor energetice și întărirea mecanismelor pieței de energie.

În cursul primei zile a Reuniunii, domnul Marc van der Woude și doamna Leigh Hancher, reprezentanți ai mediului academic, au efectuat o interesantă prezentare bazată pe raportul lor intitulat "Spre o Comunitate Europeană a Energiei: o propunere politică".

Domnul deputat Leșe a avut intervenții în cadrul dezbaterilor generale cât și în cadrul grupului de lucru nr. 3, la care a participat, cu privire la necesitatea existenței unui tratat european în domeniul energiei care să cuprindă cadrul legislativ și financiar de interconectare a rețelelor energetice, cât și un sistem european de promovare a surselor de energie regenerabile pentru reducerea emisiilor de noxe, precum și reducerea utilizării combustibililor fosili.

Participanții au optat apoi pentru a lucra în unul din următoarele trei grupuri de lucru:

1. Securitate energetică – diversitate, solidaritate și interdependență în aprovizionarea cu energie;
2. Piața unică a energiei – competiție, reglementare și politica de prețuri pentru energie;
3. Energie și mediu – energii și tehnologii noi și durabile.

În cea de-a doua zi a lucrărilor, au fost prezentate în plen rapoartele celor trei grupuri de lucru.

Au urmat declarații din partea:

- Președinției Consiliului UE (reprezentată prin domnul Marin Uribe, Secretar de Stat pentru energie din cadrul Ministerului pentru industrie, turism și comerț, Guvernul Spaniei);

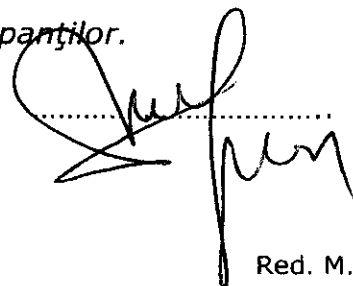
- Comisiei Europene (reprezentată prin domnul Joaquin Almunia, vicepreședinte al Comisiei Europene).

După o secțiune de dezbateri, reuniunea a fost închisă cu concluziile prezentate de domnii Jerzy Buzek, Președintele Parlamentului European, Bono Martinez, Președintele al Congresului Deputaților al Spaniei și Javier Rojo, Președintele Senatului spaniol.

Consider că România a fost subreprezentată sub aspect numeric la reuniune, având în vedere, între altele, și faptul că lucrările s-au desfășurat simultan în trei grupuri de lucru.

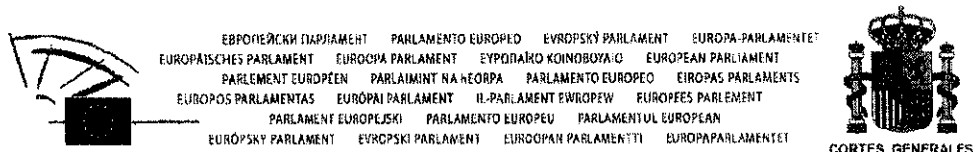
