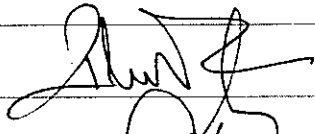
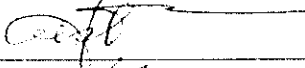
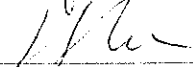
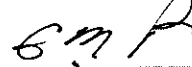
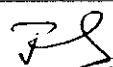
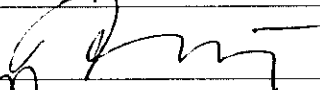
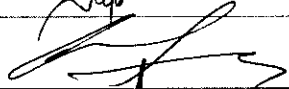
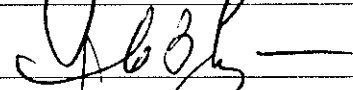
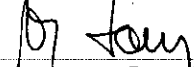
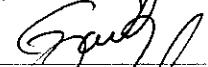
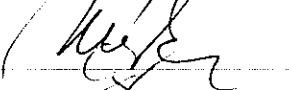
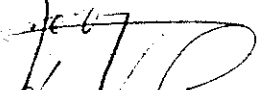
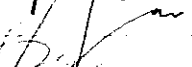
Modificarea propusă vizează modul de înregistrare a prezenței deputaților la lucrările Camerei Deputaților. În prezent, modalitatea prevăzută de Regulamentul Camerei Deputaților, respectiv, înregistrarea în condica de prezență este mai mult decât discutabilă permițând stabilirea unui cvorum de ședință fals. Pentru a elimina suspiciunile în ceea ce privește modul în care este consemnată prezența deputaților și, în consecință, consemnarea unei prezențe „false”, propun eliminarea listei de prezență și înregistrarea deputaților la începutul ședinței doar pe baza cartelei de vot. Majoritatea ședințelor Camerei Deputaților se deschid cu o prezență fictivă, bazată pe semnături care nu se susțin și în plan real. Consider că această condică de prezență este o „cutumă” care nu aduce plus valoare activității Camerei Deputaților, ba din contra.

Propunerea este susținută de un număr de deputați din toate grupurile parlamentare. Ca mărturie, anexez lista cu semnături pentru susținerea acestei propuneri. În speranța că demersul va avea câștig de cauză, sunt convinsă că nu e necesar să mai adaug argumente în ceea ce privește această condică mai degrabă a absenței decât a prezenței deputaților.

HOTĂRÂRE
privind modificarea și completarea
Regulamentului Camerei Deputaților

Camera Deputaților adoptă prezenta Hotărâre:

Articol unic – Regulamentul Camerei Deputaților, aprobat prin Hotărârea Camerei Deputaților nr. 8/1994, publicată în Monitorul Oficial al României, Partea I, nr. 50 din 25 februarie 1994, cu modificările ulterioare, se modifică și se completează după cum urmează:

Art. 141 se modifică și se completează după cum urmează:

„Art 141. alin. (1): Deputații sunt obligați să fie prezenți la lucrările Camerei. *Prezența deputaților se înregistrează electronic prin introducerea cartelei de vot în sistemul de vot electronic al Camerei Deputaților. Procedura descrisă este obligatorie și reprezintă o condiție pentru înregistrarea prezenței deputatului.*”
