Acțiunile se încadrează la art. 3, alin. c. al HBP 1/2003, modificată și completată prin HBP 5/2007.

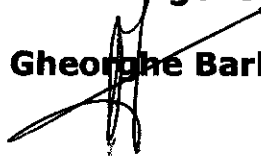
Propunem:

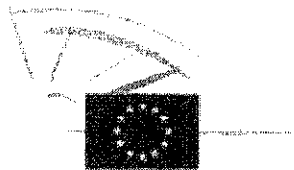
