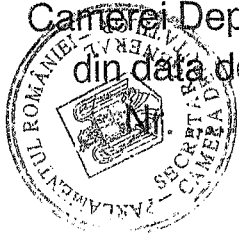

Propunem:

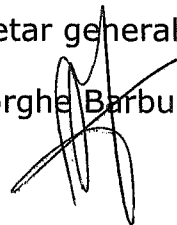
- să se aprobe participarea membrilor delegației, menționați mai sus, la această acțiune;

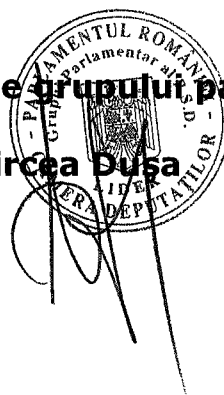
