**Tema: Participarea la Misiunea de observare a alegerilor prezidențiale din
Federația Rusă (Moscova, 1 - 5 martie 2012)**

În perioada 1 - 5 martie 2012 Adunarea Parlamentară a Consiliului Europei (APCE) va trimite în Federația Rusă o misiunea de observare a alegerilor prezidențiale programate pentru data de 4 martie a.c. Din Comisia ad-hoc constituită la nivelul Adunării Parlamentare a Consiliului Europei face parte și doamna deputată **Maria Stavrositu** (PD-L), membră a Delegației Parlamentului României la APCE.

Costurile legate de această acțiune se suportă de parlamentele naționale ai căror reprezentanți sunt membri în Comisia ad-hoc, cu excepția celor legate de închirierea de mijloace auto pentru deplasarea pe plan local și plata șoferului (cu excepția drumului aeroport - hotel și hotel - aeroport), plata translatorului pentru ziua alegerilor suportate de către Adunarea Parlamentară a Consiliului Europei.

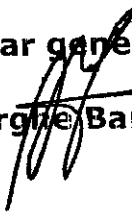

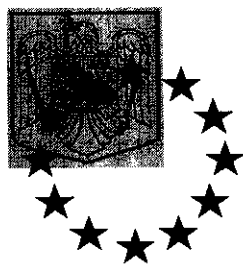
Propunem:

- să se aprobe participarea doamnei deputate Maria Stavrositu la această acțiune;
- deplasarea să se efectueze cu avionul pe ruta București - Moscova și retur, cu

plecare în data de 29.02.2012, ora 07.20 (OK 805) și întoarcere în data de 06.04.2012, ora 00.25 (OK 804), conform traseului anexat;

- să se acorde drepturi de diurnă categoria a II-a, 100 %, pentru 6 zile, cazare plafon B pentru 5 nopți, (în numerar, întrucât rezervările vor fi efectuate ulterior prin intermediul Ambasadei României în Federația Rusă);
- să se acorde un avans de 50% cu decontare ulterioară;
- recalcularea cheltuielilor să se facă la întoarcerea în țară, pe baza documentelor justificative.

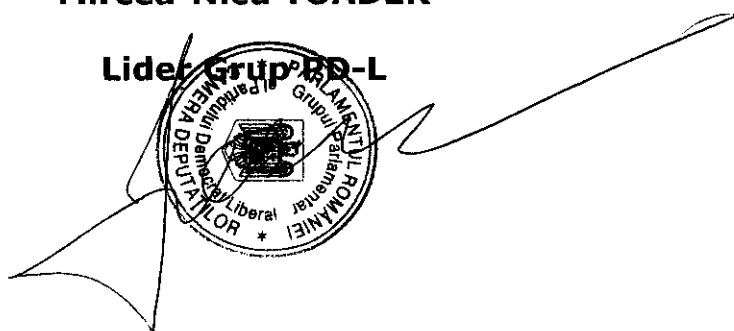

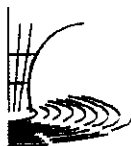
Dear Mr President,

**To the members of the ad hoc committee to observe the
Presidential Election in the Russian Federation (4 March 2012)**

Following the invitation by the Chairperson of the State Duma of the Russian Federation, the Bureau of the Parliamentary Assembly decided to set up an ad hoc committee to observe the presidential election in the Russian Federation which is scheduled to take place on 4 March 2012. The Bureau appointed Mr Tiny Kox (Netherlands, UEL) as its Chair and agreed to send a pre-electoral mission to Russia, composed of 5 members, one from each political group in the Assembly.

The ad hoc committee will meet from Thursday, 1 March 2012 to Monday, 5 March 2012 in Moscow. The programme of the meetings is being prepared and will be sent to you in due course.

The following arrangements should be made:

1. Visa

All members who need a visa to enter the Russian Federation are kindly requested to apply for one at the Consular representation of the Russian Federation in their country. In order to facilitate the application process, a copy of the invitation to observe this election is enclosed.

2. Hotel

The Secretariat has made a block-booking in the Hotel Mariott, 26/1 1st Tverskaya, 125009, Moscow, Russian Federation (Tel: +7 (495) 937 0806, Fax: +7 (495) 937 0070). The negotiated rate is 8.000 RU per night for a single room from 28.02 to 2.03.2012; 5.000 RU per night for a single room from 2 to 5.03.2012 and 8.000 RU from 05 to 6.03.2012 + 18% VAT.

You will find enclosed the registration form to be returned to the Secretariat by **10 February 2012**.

3. Transfers from airport to hotel

Exceptionally, the Secretariat is not in a position to provide members with transfers between the airport and hotel upon arrival and departure. All members are therefore asked to make their own transfer arrangements.

4. Accreditation

For accreditation, the enclosed application for accreditation as a foreign (international) observer should be completed.
