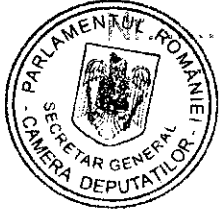

Propunem:

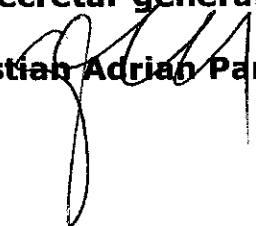

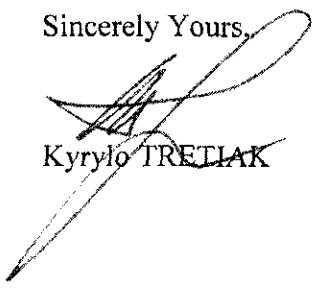

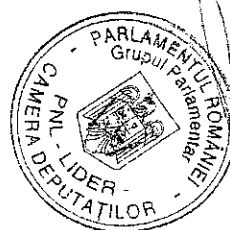
