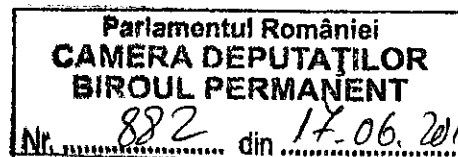

cu privire la participarea domnului deputat Andea Petru la lucrările celei de-a 45-a Adunări Generale a Adunării Parlamentare a Cooperării Economice a Mării Negre

În perioada 8-10 iunie 2015, s-au desfășurat la Chișinău, Republica Moldova, lucrările celei de-a 45-a Adunări Generale a Adunării Parlamentare a Cooperării Economice a Mării Negre (APCEMN).

La lucrările Adunării Generale au luat parte 64 de parlamentari, reprezentând forurile legislative din 11 țări membre ale APCEMN. De asemenea, au fost reprezentate un număr de 11 organizații internaționale, invitate să participe la lucrările APCEMN.

Domnul deputat Andea Petru a participat în calitate de reprezentant al Adunării Interparlamentare a Ortodoxiei (AIO), fiind membru al Secretariatului AIO.

În cadrul lucrărilor Adunării Generale a APCEMN, domnul deputat Andea Petru a prezentat un Mesaj din partea AIO, care a fost ascultat cu interes și apreciat în mod deosebit.

Domnul deputat Andea Petru a avut, de asemenea, o întâlnire de lucru cu domnul deputat Andrian Candu, Președintele Parlamentului Republicii Moldova. În discuția extinsă purtată cu acest prilej, domnul deputat Andea Petru a prezentat organizarea, misiunea și activitatea IAO, adresând invitația ca Parlamentul Republicii Moldova să-și desemneze reprezentanți la IAO. De asemenea, a reînnoit invitația ca doi reprezentanți ai Parlamentului Republicii Moldova să participe la Adunarea Generală a AIO care va avea loc la Viena, în perioada 25-29 iunie a.c. Totodată, domnul deputat Andea Petru a prezentat și aspecte din activitatea Grupului Ecumenic de Rugăciune din Parlamentul României.

Domnul Președinte Andrian Candu a concluzionat că participarea Parlamentului Republicii Moldova la activitatea IAO este benefică, putând reprezenta o punte spirituală și diplomatică în sprijinul eforturilor Republicii Moldova de a se integra în comunitatea democrațiilor occidentale.

Domnul președinte Andrian Candu a promis că, în cel mai scurt timp, va desemna doi parlamentari care să participe la Adunarea Generală a IAO de la Viena, nominalizându-l în primul rând pe domnul deputat Valeriu Streleț, prezent la discuții.

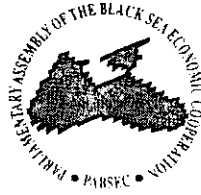
