Tema: Participarea la Conferința Femeilor Parlamentar din Sud Estul Europei, (Belgrad, Serbia, 2 - 3 martie 2015)

În perioada 2 - 3 martie 2015, se va desfășura Conferința Femeilor Parlamentar din Sud Estul Europei în Belgrad, Serbia.

Evenimentul este organizat de către Rețeaua parlamentară și Misiunea OSCE în Serbia, cu sprijinul Biroului pentru Instituții Democratice și Drepturile Omului (ODIHR).

Conferința își propune să creeze o platformă pentru o cooperare strânsă și mai substanțială între femeile parlamentar din țările din Sud-Estul Europei, prezentată într-un memorandum de înțelegere care urmează să fie convenit și semnat de către participanți.

Printre invitați se numără membri ai parlamentelor din următoarele țări: Slovenia, Croația, Bosnia și Herțegovina, Muntenegru, Macedonia, Albania, Turcia, Moldova, România, Bulgaria, Ungaria, Grecia, precum și membri ai Parlamentului European, reprezentanți ai instituțiilor relevante din Serbia, membri ai ONG-urilor de profil și organizațiilor internaționale.

Organizatorii au comunicat că delegațiile naționale trebuie să fie compuse din 2 parlamentari pentru care vor suporta toate costurile legate de transport, cazare și mese.

Din partea Camerei Deputaților au fost desemnate să participe doamnele deputat **Laura Marin (PSD)** și **Gabriela-Lola Anghel (PP-DD)**.

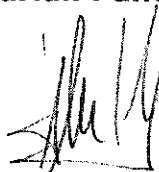
Acțiunea are caracter parlamentar conform art. 3, lit. e, al HBP 1/2003 modificată și completată prin HBP 5/2007.

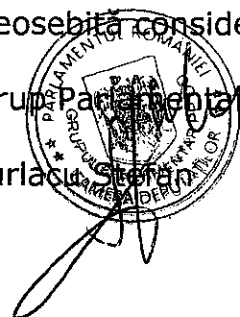

It is our pleasure to invite members of your Parliament to the conference of women parliamentarians from South East Europe that will take place from 2nd till 3rd March 2015 in Belgrade. The Conference is jointly organised by the Serbian Women Parliamentary Network and the OSCE Mission to Serbia with the support of the Office for Democratic Institutions and Human Rights (ODIHR).

The Conference will explore the role of women Members of Parliaments in closing the gender gap thus further strengthening the position of women in their respective societies. Moreover, the Conference aims to create a platform for a closer and more substantial cooperation between women MPs in SEE countries outlined in a Memorandum of Understanding to be agreed upon and signed by the participants.

Invited participants include Members of Parliaments from SEE countries (Slovenia, Croatia, Bosnia and Herzegovina, Montenegro, Macedonia, Albania, Turkey, Moldova, Romania, Bulgaria, Hungary, and Greece), Members of the EU Parliament, representatives of the Women in Parliaments Global Forum, representatives of the relevant institutions from Serbia, members of NGOs and international organisations.

Delegations should be composed of two MPs, ideally representatives of women caucus or relevant committee. Inputs and opinions of both the ruling party and the opposition are very much appreciated. The meeting will be held in Serbian with simultaneous interpretation from/to English.

Together with this invitation, please find enclosed a concept paper with preliminary agenda of the conference, and registration form.

The costs of travel, accommodation and meals will be provided by the organisers. For logistical details please be in touch with our colleagues from the OSCE Mission to Serbia as indicated in the Registration Form.

I Background

The Women Parliamentary Network of the National Assembly of the Republic of Serbia (WPN) was established on 14 February 2013, as an informal network of women MPs from all political parties represented in the Serbian Parliament.

To date the WPN has achieved significant results in improving the position of women in Serbia. It has become a recognised actor in the field of gender equality both nationally and regionally. Recognising the importance and benefits of networking amongst women politicians at all levels, the WPN would like to incite regular meetings of women parliamentarians from SEE share their experience with each other and discuss issues of common concern.

Therefore, the Women Parliamentary Network is organising a conference to gather women parliamentarians from SEE and explore possibilities of future cooperation.

The Regional Conference will take place on 2-3 March 2015 in Belgrade at the House of the National Assembly of the Republic of Serbia.

II Program

This two-day conference will be dedicated to the initial insight in gender equality state of art in individual parliaments/countries, and to the exchange of best practices on three topics in three panel discussions.

One representative per Parliament will be given up to 10 minutes time to present key issues surrounding gender equality state of art and trends in their respective countries/parliaments including regulatory and institutional frameworks.(Special questionnaire to be prepared in order to achieve that all important elements are presented in all reports)

After the plenary session, the participants will be divided into three groups/panels dedicated to the following topics:

- a) Building power of women in parliamentary political parties,
- b) Impact of cross party cooperation of women MPs on processes and policies promoting empowerment of women and enjoyment of their indivisible human rights
- c) Implementation of the Istanbul Convention.

Afterwards the participants will discuss the topic of economic empowerment of women and exchange their views and relevant practices applied in their respective countries.

The second day of the Conference will include a panel organized in close cooperation with the Women in Parliaments Global Forum.

The Conference will result in a signed Memorandum of Cooperation in which the women parliamentarians will define their cooperation modalities. Draft Memorandum of Understanding will be prepared by the Serbian Women Parliamentary Network in advance and shared with the participants for their consideration **at least one month prior to the date of the Conference.**

The Conference will also yield recommendations regarding possible improvements of the current situation in the explored fields.

III Participation

The Conference will gather Members of Parliament, representatives of the executive branch of power, nongovernmental organizations, international organizations, independent experts, and academia.
