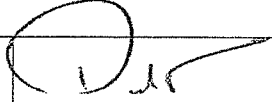
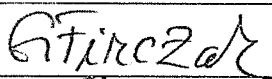
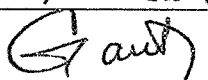
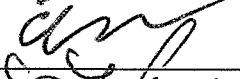
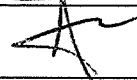
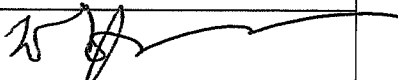
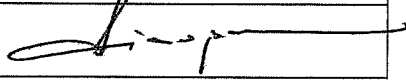
Expunere de motive

Hotărâre

privind completarea articolului 113 al Regulamentului Camerei Deputaților

Articol unic: Articolul 113 se completează cu două aliniate noi având următorul cuprins:

„(2¹) Pentru propunerile legislative termenele de legiferare curg de la data înregistrării acestora la Biroul permanent, însoțite de avizele necesare.

(2²) Pentru termenele procedurale ale procesului legislativ se iau în calcul numai zilele în care Camera Deputaților lucrează în plen sau în comisii permanente.”
