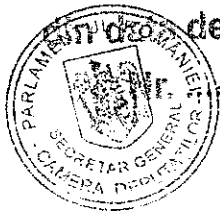

Tema: Organizarea celei de-a 47-a reuniuni a Comisiei de cultură, educație și afaceri sociale a APCEMN (25-26 octombrie 2016, București, Palatul Parlamentului)

În perioada 25-26 octombrie 2016, urmează să aibă loc la București, cea de-a 47-a reuniuni a Comisiei pentru cultură, educație și afaceri sociale a Adunării Parlamentare a Cooperării Economice a Mării Negre (APCEMN) care, la propunerea delegației României, va avea ca temă de dezbatere: "Educație și știință pentru dezvoltare durabilă în statele membre ale OCEMN".

Această reuniune reprezintă o bună oportunitate pentru menținerea excelenței cooperării dintre Parlamentul României și APCEMN și pentru ca membrii APCEMN să devină mai familiarizați cu recente evoluții ale sistemului educațional al țării noastre.
