



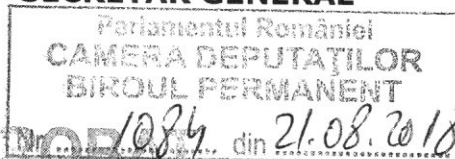

Tema: Participarea la Forumul Economic de la Krynica

(Krynica Zdrój, Polonia, 4 – 6 septembrie 2018)

În perioada 4 - 6 septembrie 2018, la Krynica Zdrój, Polonia, va avea loc cea dea 28-a ediție a Forumului Economic de la Krynica, intitulată "O Europă a Valorilor Comune sau o Europă a Intereselor Comune?", la această acțiune urmând să participe domnul deputat **Ben-Oni ARDELEAN (PNL)**, vicepreședinte al Camerei Deputaților.

Domnul deputat Ben-Oni ARDELEAN este invitat să contribuie la lucrările Forumului și în calitate de orator la sesiunea cu tema "Provocări vechi și noi în regiunile Mării Baltice și Mării Negre."

În cadrul Forumului, se vor desfășura 6 Sesiuni Plenare, peste 180 de sesiuni de dezbateri, prezentări și grupuri de lucru. Pe agenda evenimentului figurează o serie de teme precum: Europa și Lumea; investiții și dezvoltare; macroeconomie; securitatea informațională; conceptul de "New Economy"; conceptul de "Silver Economy"; statul și reformele; politica la nivel internațional.

Organizatorii au anunțat că peste 4000 de invitați din Europa, Asia, SUA și Orientul Mijlociu vor lua parte la lucrările Forumului, printre aceștia numărându-se lideri politici, parlamentari, înalți oficiali guvernamentali, reprezentanți ai mediului academic, ai ONG-urilor, precum și ai mediului privat.

Menționăm că organizatorii asigura cazarea participanților.

Acțiunea are caracter parlamentar conform art. 3, alin. e) din HBPr nr. 1/2003, cu modificările și completările ulterioare.

Propunem:

- să se aprobe participarea domnului deputat Ben-Oni ARDELEAN la această acțiune;

- deplasarea să se efectueze cu avionul, clasa economic, pe ruta București – Varșovia – Cracovia – Viena - București, cu plecare în data de 4 septembrie 2018, ora 05:35 cu zborul LO644 și întoarcere în data de 6 septembrie 2018, ora 20:10 cu zborul OS 787, conform itinerariului anexat;
- să se acorde drepturi de diurnă categoria a II-a, 100%, pentru 3 zile, majorată conform art.27, alin. 2, lit. a, din HBPr nr. 1/2003 cu modificările și completările ulterioare. Serviciile de cazare sunt asigurate de organizatori;
- să se acorde un avans de 50% cu decontare ulterioară și, totodată, să se suporte din acesta eventualele taxe de oraș percepute de hotel;
- să se suporte din bugetul Camerei Deputaților costul transportului rutier de la Aeroportul din Cracovia la Krynica Zdrój și retur, în conformitate cu art. 37 alin. 1, lit. C din HBPr nr. 1/2003 cu modificările și completările ulterioare;
- să se suporte din bugetul Camerei Deputaților cheltuielile privind serviciile de asigurare contra accidentelor și asigurare de sănătate pentru membrii delegației, în perioada efectivă de deplasare;
- decontarea cheltuielilor să se facă la întoarcerea în țară, pe baza documentelor justificative.
