Tema: Participarea la conferința interparlamentară cu tema "Rolul parlamentelor naționale în modelarea viitorului din sectorul alimentar și agricultură"

Zagreb, Croația, 22 – 23 noiembrie 2018

Comisia pentru Agricultură a Parlamentului croat va organiza în perioada 22 – 23 noiembrie 2018, la Zagreb, conferința interparlamentară cu tema "Rolul parlamentelor naționale în modelarea viitorului din sectorul alimentar și agricultură", în contextul elaborării de către Comisia Europeană a noilor regulamente și propuneri de modernizare a principalului cadru de reglementare privind dezvoltarea rurală în Uniunea Europeană (Politica Agricolă Comună-PAC).

Punctul principal de pe agenda conferinței este prezentarea propunerilor legislative pentru noul cadru al Politicii Agricole Comune în perioada 2021-2027 de către Comisarul european pentru agricultură și dezvoltare rurală, domnul Phil Hogan, care va fi urmată de patru sesiuni de dezbateri, pe următoarele teme: *Procesul adoptării planurilor de strategii naționale, Reînnoirea generațiilor de fermieri, Comunitatea locală și dezvoltarea rurală, Cercetarea în agricultură, siguranța și calitatea în sectorul alimentar.*

Conferința interparlamentară de la Zagreb, va aduce alături de reprezentanții Comisiilor pentru agricultură din parlamentele naționale ale țărilor membre UE, reprezentanții Comisiei pentru agricultură și dezvoltare rurală din Parlamentul European, reprezentanți ai Comisiei Europene, Ministerului agriculturii din Croația și ai asociațiilor de dezvoltare sectorială.

Din partea Camerei Deputaților, va participa la această reuniune, domnul deputat **Alexandru STĂNESCU (PSD)** în calitate de președinte al Comisiei pentru agricultură, silvicultură, industrie alimentară și servicii specifice. Domnul

deputat va fi însoțit de doamna Alexandra Simionel, consilier parlamentar în cadrul Comisiei.

Menționăm că organizatorii asigură cazarea pentru toți participanții pe perioada desfășurării lucrărilor Comisiei.

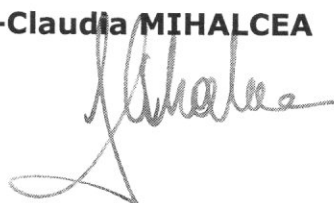

Propunem:

- deplasarea să se efectueze cu avionul, clasa economic, pe ruta București – Munchen - Zagreb – Frankfurt – București, cu plecare în data de 21 noiembrie a.c. ora 18:35, zborul nr. LH 1655, și întoarcere în data de 23 noiembrie a.c., ora 23:45, zborul nr. LH 1422, conform traseului anexat și solicitării din partea domnului deputat;
- să se acorde domnului deputat drepturi de diurnă categoria a II-a, 100%, pentru 2 1/2 zile, majorată conform art.27, alin. 2, lit. a, din HBP nr. 1/2003 cu modificările și completările ulterioare din HBP nr. 5/2007;
- să se acorde doamnei consilier Alexandra Simionel drepturi de diurnă categoria a II-a, 100%, pentru 2 ½ zile;
- să se acorde un avans de 50% cu decontare ulterioară și, totodată, să se suporte din acesta eventuale alte taxe suplimentare precum taxele de oraș sau de sejur percepute de hotel;
- să se suporte din bugetul Camerei Deputaților cheltuielile privind serviciile de asigurare contra accidentelor și asigurare de sănătate pentru membrii delegației în perioada efectivă de deplasare;

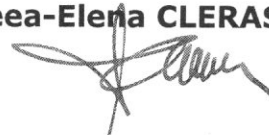

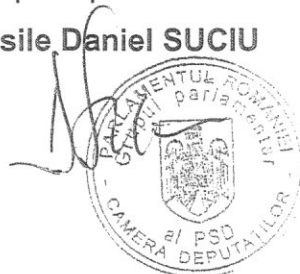

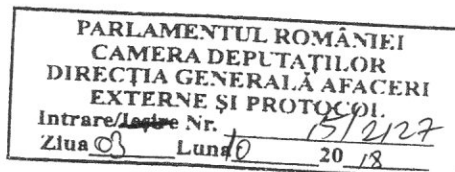

I have a pleasure of informing you that the Agriculture Committee of the Croatian Parliament, supported by the Ministry of Agriculture of the Republic of Croatia, will organize an interparliamentary conference with the aim of fostering interparliamentary cooperation between the competent working bodies of national parliaments, exchanging views and discussing the proposal for the legislative framework of the Common Agricultural Policy for the forthcoming programming period, presented by the European Commission at the beginning of June 2018.

Along with representatives of the committees responsible for agriculture and rural development of EU member states' national parliaments, the conference will also bring together representatives of the Committee on Agriculture and Rural Development of the European Parliament, the European Commission, the Ministry of Agriculture of the Republic of Croatia and major sectoral associations.

In my capacity as the Chairman of the Croatian Parliament Agriculture Committee, it is my pleasure to invite you and the members of your Committee to the **Interparliamentary Conference "The Role of Parliaments in Shaping the Future of Food and Farming"**, to be held on 22 and 23 November 2018 in the Croatian Parliament.

The legislative framework proposal will be presented by the Commissioner for Agriculture and Rural Development Phil Hogan, followed by a discussion on: the process of adopting national strategic plans, generational renewal of rural areas, research in agriculture, food safety and quality and local community and rural development. The second day of the Conference will be reserved for the presentation of the outcomes of the discussions and exchange of views between parliamentarians and representatives of sectoral associations and proposing the topics for further discussions between national parliaments on the future of the Common Agricultural Policy beyond 2020.

With a view to ensuring a constructive discussion, we would appreciate if you provided the views and opinions of your Committee on the proposal for a legislative framework of the Common Agricultural Policy and the related proposal for the Multiannual Financial Framework for the next programming period by 15 October 2018.

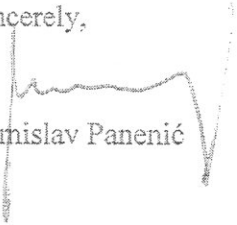

All Sessions are related to the new legislation framework of the Common Agricultural Policy. Second day of the Conference plans to present the summaries from the Sessions presented by the rapporteurs and discussion among national Parliaments and the European Parliament as well as representatives of the professional associations on the future of the Common Agricultural Policy. Closing part of the Conference plans topics for further discussions among national Parliaments on the new legislation framework of the Common Agricultural Policy.

By Taxi
