Tema: Participarea doamnei deputat Oana Consuela Florea la cea de-a 114-a sesiune plenară a Comisiei de la Veneția (Veneția, 16-17 martie 2018)

În perioada 16 – 17 martie 2018, se va desfășura, la Veneția, cea de-a 114-a sesiune plenară a Comisiei europene pentru Democrație prin Drept (Comisia de la Veneția).

Cu această ocazie va fi examinată opinia comună a Comisiei de la Veneția și a Biroului pentru Instituțiile Democratice și Drepturile Omului (ODHIR/OSCE) asupra compatibilității cu standardele în domeniu a proiectului de lege nr. 140/2017 prin care se amendează OG nr. 26/2000 privind asociațiile și fundațiile.

La propunerea Ministerului Afacerilor Externe, la această reuniune, alături de reprezentanți ai autorităților române, va participa și un reprezentant al Camerei Deputaților, în acest sens fiind desemnată doamna deputat **Oana Consuela FLOREA (PSD)**, membră a Comisiei comune permanente a Camerei Deputaților și Senatului pentru exercitarea controlului parlamentar asupra activității SRI.

Acțiunea are caracter parlamentar conform art. 3, lit. f din HBPr 1/2003 cu modificările și completările ulterioare din HBPr 5/2007.

Propunem:

- să se aprobe participarea doamnei deputat Oana Consuela Florea la această acțiune;
- având în vedere participarea domniei sale în continuarea acțiunii de la Veneția la reuniunea Grupului comun de control parlamentar specializat al Europol, în perioada 18-20 martie 2018 (M.I. 224/26.02.2018), deplasarea să se efectueze cu avionul, clasa economic, pe ruta București – Viena – Veneția – Viena – Sofia – București, cu plecare în data de 15 martie 2018, ora 13:35 (OS 784) și întoarcere în data de 20 martie 2018, ora 10:55 (RO 292), conform itinerariului anexat. Prevederile privind transportul din prezentul Memorandum Intern le înlocuiesc pe cele din MI. 224/26.02.2018;
- să se acorde drepturi de diurnă categoria a II-a, 100%, pentru 2 ½ zile, și cazare plafon B pentru 3 nopți, în numerar;

- să se suporte din bugetul Camerei Deputaților cheltuielile privind serviciile de asigurare contra accidentelor și asigurare de sănătate pentru întreaga perioadă de deplasare;
- să se acorde un avans de 15% cu decontare ulterioară și, totodată, să se suporte din acesta eventuale alte taxe suplimentare precum taxele de oraș sau sejur percepute de hotel;
- decontarea cheltuielilor să se facă la întoarcerea în țară, pe baza documentelor justificative.

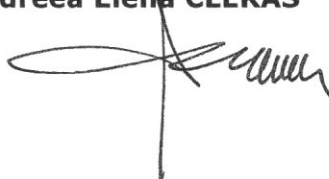

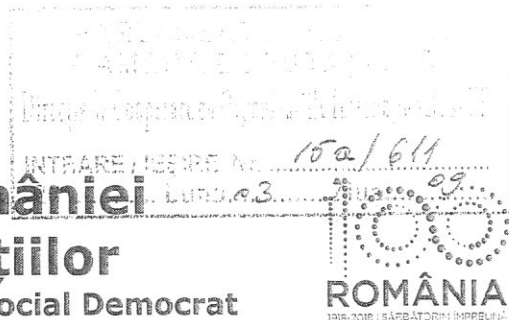

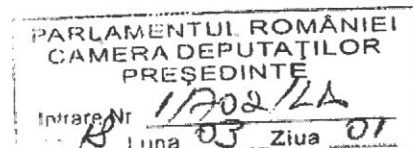
