

EXPUNERE DE MOTIVE

La modificarea si completarea Legii 105/1999

Urmare a sesizarii si interpelarii primite de la Domnul Tanase Dumitru, care in numele cetatenilor din Tg.Frumos, Pascani, Ruginoasa, Motca, Timisesti si alte localitati din Judetul Iasi si Judetul Botosani, arata ca in timpul celui de-al doilea razboi mondial (perioada 1943-1944) au fost evacuati (stramutati) in alte localitati decat cele de domiciliu.

Atat Primariile localitatilor evacuate, Primariile localitatilor in care au fost stramutati cat si Arhivele Statului nu pot elibera adeverinte persoanelor in viata conform Ordonantei de Guvern nr.105/1999 art.6, pentru a beneficia de acordarea unor drepturi prevazute in lege.

Cum dovedirea situatiei prezentate de persoane interesate, conform art.1 din Legea nr.105/1999, nu se poate face cu acte eliberate de organele competente, se impune un alt mijloc de proba (prevazut de lege), intrucat in lege nu este definit in mod clar expresia : "orice mijloc de proba".

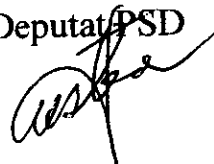
In acest sens se impune introducerea declaratiei autentice in forma notariala care sa ateste incadrarea persoanelor interesate in prevederile art.1 din Legea 189/2000 privind acordarea unor drepturi persoanelor persecutate de catre regimurile instaurate in Romania in perioada 6 Septembrie 1940 – 6 Martie 1945.

Astfel venim in sprijinul solicitantilor mai rapid si mai eficient, avandu-se in vedere varsta inaintata a acestora.

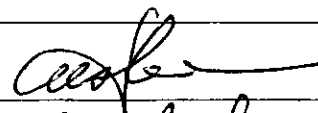
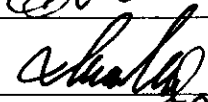
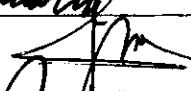
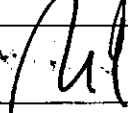
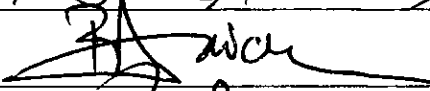
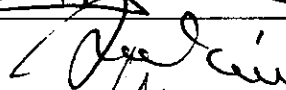
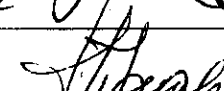
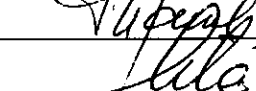
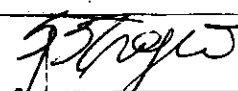
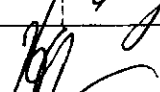
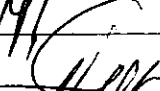
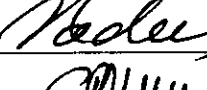
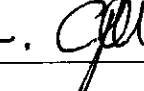
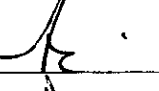
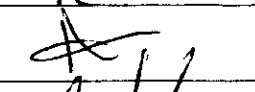
